ORDER

Government are pleased to declare Tuesday 9th December , 2025 and Thursday 11th December , 2025 as public holidays for all Public Offices and Educational Institutions and Paid Holidays for Commercial Undertakings in the State, in connection with the General Election to the LSGs 2025. The holidays are to be observed district-wise as follows:-

- 9.12.2025, Tuesday, 2025 is declared as holiday in the districts of Thiruvananthapuram, Kollam, Pathanamthitta, Alappuzha, Kottayam, Idukki, and Ernakulam.
- 11.12.2025, Thursday, 2025 is declared as holiday in the districts of Thrissur, Palakkad, Malappuram, Kozhikode, Wayanad, Kannur, and Kasaragod.
- 2) Government employees who are voters of the Local Self-Government Constituency where poll is taking place, but serving/employed in an office/institution located in the districts where the holiday is not observing may be granted Other Duty status, or any Special Leaves available in SPARK (excluding Casual Leave, Commuted Leave, or Earned Leave), as per their convenience, on the election dates. The employee, applying for such leave, shall convince

the Controlling Officer/Superior Officer with documentary evidence that he/she is a voter in the said Local Self-Government constituency.

- 3. As per Section 145 A of the Kerala Panchayat Raj Act, 1994, and Section 202 A of the Kerala Municipality Act, 1994, every person employed in any commercial establishment, trading establishment, industrial establishment, or any other establishment in the private sector, and who is entitled to vote in the Panchayat/Municipality election, shall be granted a holiday on the day of the General Election. It is also stipulated that no deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in this manner.
- 4) The Labour Commissioner will make necessary arrangements with all Private Enterprises including IT sector, Private Industrial centers and other Private Institutions under the Shops and Commercial Establishment Act to declare the day of poll viz: the above said days as paid holiday for all their employees. No deduction or abatement of the wages of any such persons shall be made on account of a holiday having been granted in accordance with law and if such person is employed on the basis that he would not accordingly receive wages for such a day, he shall nonetheless be paid for such a day, the wages he would have drawn had not a holiday been granted to him on that day.
- 5) Employees including daily wage/casual workers who are voters of a Constituency where poll is taking place, but serving/employed in an industrial undertaking or an establishment located outside that constituency where he/she is resident have to be given the benefit of paid holiday on the day of poll.
